

Hilbert Invite

Friday May 8, 2015

Host – Hilbert High School

Place: Hilbert High School Track – 1139 W. Milwaukee St.

Schools: Gibraltar, Hilbert-Stockbridge, Iola-Scandinavia, Kaukauna, St. Mary Central, Suring, and Wrightstown

Facilities: Eight lane 400 meter rubberized track and jumping surfaces.

Only 1/8 inch pyramid spikes allowed – thank you.

Shot and Discus circles are both concrete.

Buses: Please park behind the school by the track

Admission: Adults: \$4.00 Students: \$3.00

Athletic Trainer: Jessica Schmidt from Affinity will be available throughout the meet and will be located on the infield at the finish-line area.

Locker Rooms: There will be no locker rooms available. Restrooms will be available and will be located by the concession stand and the field events.

Bullpen: The bullpen will be located at the start line for the 110 hurdles. All participants must report to the Clerk of Course in this area, including all members of relay teams.

Camps: All team camps must be set up on the west side of the track outside of the fence.

Restricted Areas: Only athletes in a current event are allowed on the infield. All coaches and spectators are NOT allowed in this area. In addition only those individuals with wristbands will be allowed in restricted areas at the field events.

Concessions: Will be available from approximately 3:30 throughout the meet.

Awards: Team plaques will be awarded to the boys and girls champion as well as the combined team champion. No medals for individual events.

Scoring: Team scoring will consist of 8 places (10-8-6-5-4-3-2-1) in all events.

Entry Fee: \$150– Please try to mail before the meet. Thank You!

Entries: A school may enter up to 3 athletes per event and 1 team per relay with a maximum of 28 individual entries. Please remember that being listed as an alternate counts as an event for that individual.

Entry Forms: Entries will be accepted on-line only. We will be using Prime Time Timing for On-line entries. Log on to www.pttiming.com to submit entries. You must have your entries submitted by: Wednesday May 6 @ Noon

There will be a \$50 fine for late entries.

Heat sheets will be available at Prime Time Timings website.

Changes: Scratches will be allowed the day of the meet but replacements will only be allowed

with a physician's note. In the case of a scratch or a replacement, we will not re-seed the event.

Running Events: In the trials (high hurdles and 100 dashes) the 1st place winners of each heat and the next fastest times from all the heats will make the finals. For races run in sections, the slowest section will be run first.

Field Events: Preliminaries will be conducted in the shot put, discus, long jump, and triple jump. Each competitor will receive 3 attempts with the best 9 qualifying for finals. Athletes will receive 3 additional attempts in finals. The "open pit" system will be used in the long and triple jumps with trials scheduled from 4:00 to 5:30 and finals run from 5:45 to 6:45. Girls shot, boys disc, boys pole vault, and girls high jump will go first. As per WIAA rule, there will be no tape allowed on the runways.

Exchange Zones: To insure fair exchanges during the relays, we need the help of coaches during the following races.

800 Relay: Hilbert – incoming
Iola-Scandinavia – outgoing

400 Relay: 1st exchange – St. Mary Central – incoming
Kaukauna – outgoing
2nd exchange – Wrightstown – incoming
Hilbert – outgoing
3rd exchange –Gibraltar– incoming
Suring – outgoing
