

Dear Coach:

The 43rd Annual Druckrey Invitational Cross Country Meet is set to go on Saturday, September 9. The Time schedule is as follows:

8:00 am – Course Opens	10:55 am – Girls Varsity
9:30 am – Girls JV	11:35 am – Boys Varsity
10:15 am – Boys JV	12:20 pm – Awards Presentation

Teams involved in this years meet are: Brookfield Central, Kenosha Bradford, Kenosha Tremper, Lake Country Lutheran, Madison Memorial (boys), Milw. King, Milw. Salam, Milw. Reagan, Oak Creek, Oshkosh West, Racine Case, Racine Horlick, Racine Lutheran, Racine Park, Waukesha West, Wauwatosa West, West Allis Hale, Wisconsin Lutheran (girls).

The meet will take place in Grant Park. The course is mostly grass with the runners crossing the park roads and asphalt bike path several times. Spikes can be worn. The course will be lined and flagged. All athletes will run 5,000 meters.

T-SHIRTS: Can be ordered online at Ultimate Screen Print and must be picked up at the meet. No shirts will be mailed. Some shirts will be sold at the meet. ALL MEET ENTRIES ARE HANDLED by PT Timing, LLC. All entries will be submitted on pttiming.com website. 1. Click "Upcoming Events. 2. Click on Stan Druckrey Invite. Follow directions and fill in your team's name and athletes names. You will be asked to declare your Varsity runners but, meet day changes will be allowed. See below. (this is a manual process that will require you to enter each athlete's name. You do not have to enter the athletes' names again in future meets that use PT Timing services later in the season).

ENTRIES ARE DUE ON THURSDAY, SEPTEMBER 7 AT NOON - 12:00 PM

DO NOT CONTACT South Milwaukee or Stan Druckrey if you MISS the entry deadline. It is your responsibility to enter your team on the PT Timing website. There will be a \$50.00 late fee.

Varsity and JV. Coaches will need to declare their Varsity Runners. The varsity team can consist of 8 or less runners. The remaining runners will then be declared JV. You will be asked to declare your Varsity Athletes on the entry page of PT Timing. You will be allowed to 'switch' Varsity & JV athletes on meet day.

Chip Timing: The races will be timed by PT Timing, LLC. Each runner will get a bib number with the timing chip attached.

Entries: please do not enter athletes who you know will not be competing. Every athlete that is entered on the PT Timing website will be assigned a chip. This cost \$1.50 per athlete whether he/she competes or not. Last year it cost over \$50.00 for athletes who did not run.

Buses will not be allowed to park in Grant Park unless there is inclement weather. Please tell your bus driver to park at the high school and pick up your team after the award ceremonies (12:45 pm). Course map & parking areas can be found on our website – www.southmilwaukeecrosscountry.com

It is very important that you remind your parents and fans that they may have to park on city streets if the parking lots in the park are full. This could happen as early as 9:15 am. It is much easier leaving the meet when you park on city streets. There is parking on the west side of Lake Drive. Signs will be posted on Lake Drive to show people how to get to the CC course. The south entrance to the Park by the golf course clubhouse will be closed until 12:30 pm.
