- FACILITY:** Warm ups will take place on the grass area behind the concession stand where team camps are located. **BESIDES HURDLERS WARMING UP NO ONE WILL BE ALLOWED ON THE INFELD TO WARM UP.**

The track and jumping surfaces will accommodate a maximum ¼” spike length

Discus and shot put areas are concrete and located outside the stadium. The Shot Put and Discus areas are on the southeast side of the stadium.

There will be a coach's box for High Jump, Pole Vault, Long Jump and Triple Jump.

SPECTATORS WILL NOT BE ALLOWED ON THE FIELD.

NO TAPE MARKS ARE ALLOWED ON THE TRACK – Chalk can be used for "marks".

PLEASE PICK UP ALL THE GARBAGE BEFORE YOU LEAVE

SCRATCHES:

Meet managers have no authority to allow substitutions in individual events on the day of the meet, except: if a coach presents a medical statement that a student cannot participate, or if the WIAA approves a change.

Individuals involved in substitution will not be reseeded, but will assume the same section, heat, lane, and/or flight assignment of the original entry(s).

An individual may scratch from part of the meet without having to scratch from the entire meet.

An individual who is already entered in an event(s) cannot scratch from one event to replace an individual in another event

PRIME TIME TIMING:

PT Timing will seed the meet, post heat/flight sheets, entry lists and results on line as soon as they are available

TRAINER:

A certified Athletic Trainer will present and located near the finish line throughout the entire day and will have an AED on hand.

**EMERGENCY
ACTION PLAN:**

Attached in the email is the Emergency Action Plan

In the event of lightning please have your athletes make their way to door 13 behind the soccer field near the small parking lot in back and we will have them go into our fieldhouse.

CONCESSIONS:

Concessions will be available at the stadium throughout the day

RUNNING EVENTS:

Running events will start @ 4:45

All runners in open events will be assigned a hip number and only anchor runners in relays will be assigned hip numbers

FIELD EVENTS:

Field events will start @ 4:00

Implements will be weighed and inspected in the garage near the discus area on the east side of the track from 2:30-3:15. Impounded implements will be available for pick after the meet in the garage.

Vaulting poles will be inspected at the vault area. Any improper poles will

need to be corrected before being allowed for use in the meet. **ALL VAULTERS (BOYS AND GIRLS) SHOULD COME TO THE POLE VAULT AREA IMMEDIATELY UPON ARRIVAL WITH THEIR WEIGH-IN SHEETS TO HAVE THEIR POLES INSPECTED.**

NO TAPE MARKS ARE ALLOWED ON THE TRACK – Chalk can be used for “marks”.

An athlete who checks out from a field event will have up to 15 minutes to return to their event, after their name is called for their attempt, not from the time they check out. Event judges will mark when the athlete checked out and note the time once their name is called in the rotation.

Time limits after being called for the next attempt are going to be enforced uniformly. Please inform your athletes regarding time limits.

Pole Vault – Boys will vault to completion followed by 20 minutes for gender change and warm-ups (5 Alive will be used). Pole Vault will go up 6” until 6 vaulters are left, then 3”.

High Jump – Girls High Jump will continue until completion followed by 20 minutes for gender change and warm-ups (5 Alive will be used). High jump will go up 2” until 6 jumpers are left, then 1”.

Shot Put & Discus – Girls Shot Put & Boys Discus will continue until completion followed by 20 minutes for gender change and warm-ups. Each competitor will be given 3 throws in the prelims and finals. There will 10 minutes between seeded prelims and seeded finals.

Long Jump & Triple Jump – Girls Long Jump and Boys Triple jump will continue until completion and then followed by 20 minutes for gender change and warm-ups. Prelims will consist of 45 minutes for OPEN PIT, followed by a 10 minute break and 30 minutes for seeded finals. Each competitor will be given 3 jumps in the prelims and finals.

SCORING:

Scoring will be 8 places with the top 3 finalists in each even advancing to the WIAA State Meet.

A run-off procedure in running events or regular tie breaking procedure in field events, if needed, to break ties regarding 1st, 2nd & 3rd places.

BULLPEN:

Please have athletes report to the bullpen on the first call

The bullpen will be located at the end of the track near the starting line

RESTRICTED AREAS:

Non-participating athletes and spectators will not be allowed inside of the fence surrounding the track

Athletes will not be allowed to linger on the turf inside of the track.

**ALL COACHES MUST BE WEARING THEIR WRISTBAND TO BE
ALLOWED WITHIN THE RESTRICTED AREAS**
